About RAINS

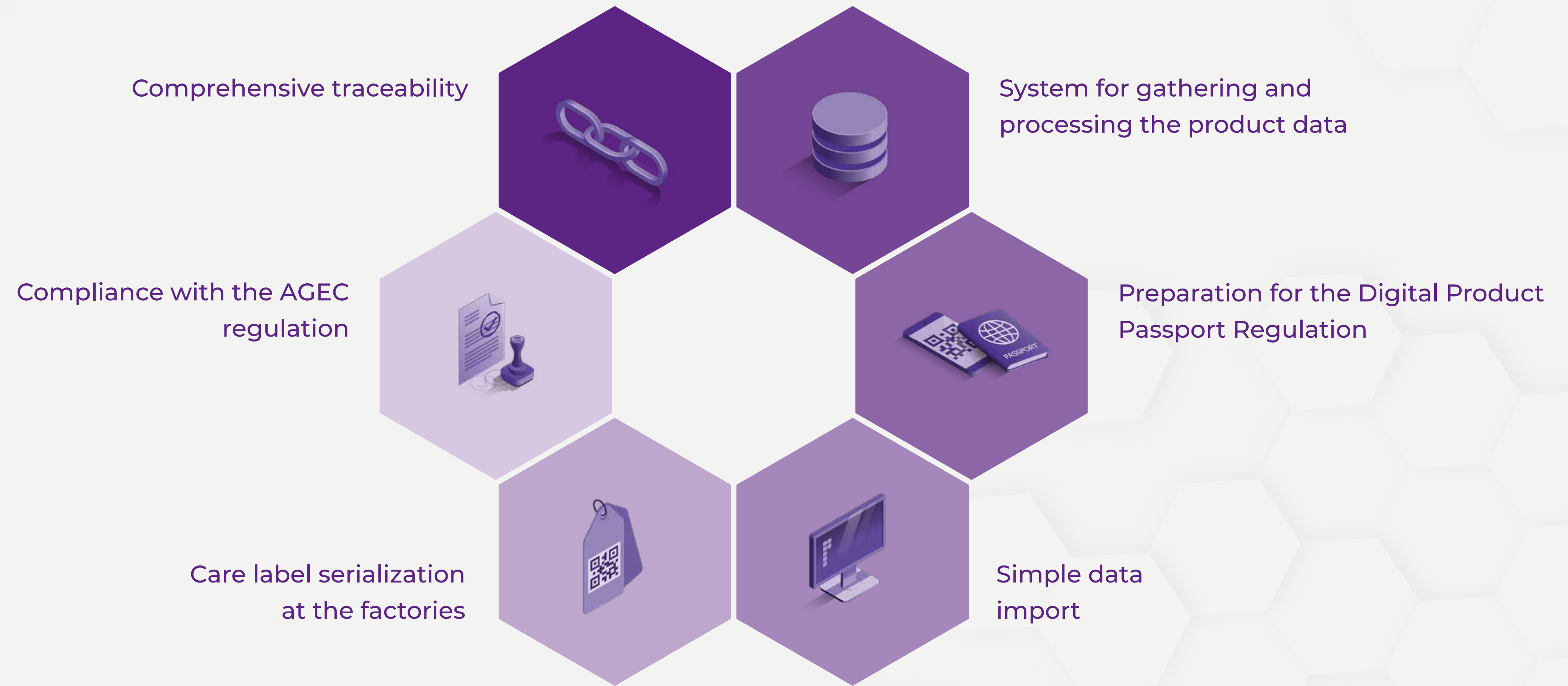
RAINS is a Danish outerwear lifestyle brand established in 2012, renowned for its fusion of conceptual and functional design with urban inspiration

RAINS reached out to PSQR for a traceability solution to ensure **AGEC compliance, streamline QR code labeling, and consolidate product data for regulatory readiness.**

Problem statement



Challenges & Pain Points

Primary Challenge:

RAINS needed to comply with AGEC regulations, but they lacked a system to:

- ❏ Display AGEC-required attributes for each product.
- ❏ Generate QR codes for product labels.

Impact on Operations & Business:

- ❏ **Regulatory Risk:** Non-compliance would prevent RAINS from selling products in France.
- ❏ **Lack of Automation:** No streamlined process for QR code generation and data exposure.
- ❏ **Operational Inefficiencies:** Data was fragmented, making compliance difficult and time-consuming.



Limitations of the previous approach

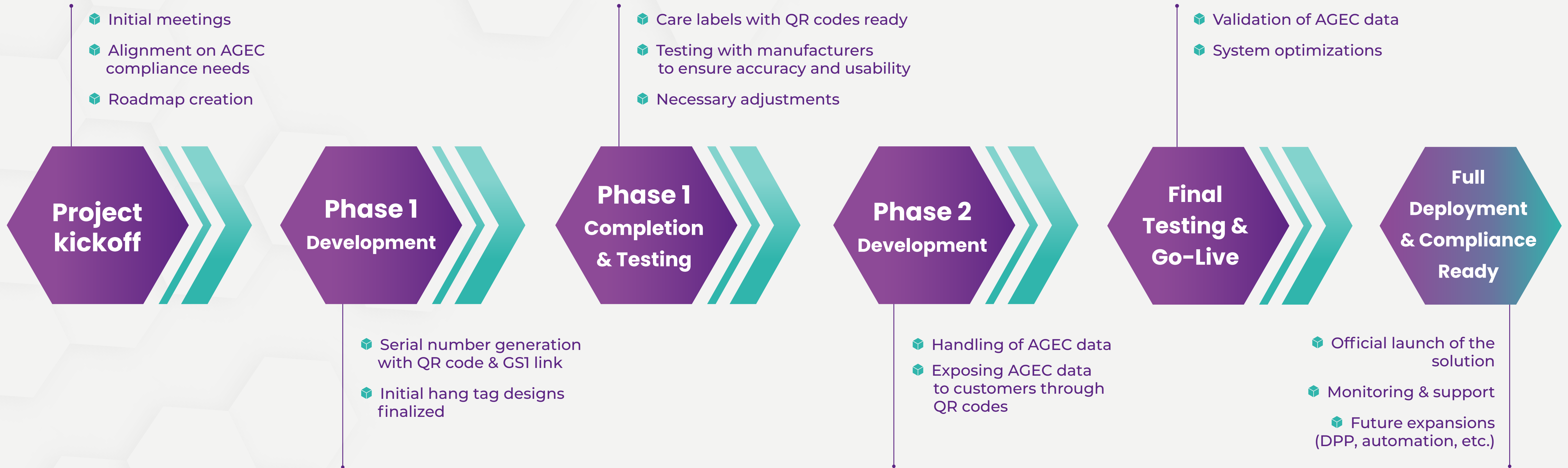
- ❖ **No QR Codes:** Manually generated labels lacked scannable QR codes, preventing customers from accessing product information.
- ❖ **Fragmented Data:** AGECE compliance data was not consolidated or accessible to customers.
- ❖ **No Compliance Assurance:** No system existed to collect, validate, and link required attributes to Rains products.

Key Limitations:

- ❖ Manual processes increased the risk of errors and inefficiencies.
- ❖ Lack of automation made compliance difficult to scale.
- ❖ Regulatory non-compliance could result in restricted market access in France.



How we did it



Implementation Process: Agile & Milestone-Based Approach

The project was executed using a Scrum agile framework, with regular collaboration between the PSQR team and RAINS to refine the solution based on RAINS' real needs.

Milestone 1: Care label generation with QR codes at factories

- ❖ **Priority:** Fast implementation to ensure manufacturers could use the new system immediately.
- ❖ **Timeline:** Focused on early weeks of the project to meet urgent production needs.

Milestone 2: AGEC data upload & public frontend readiness

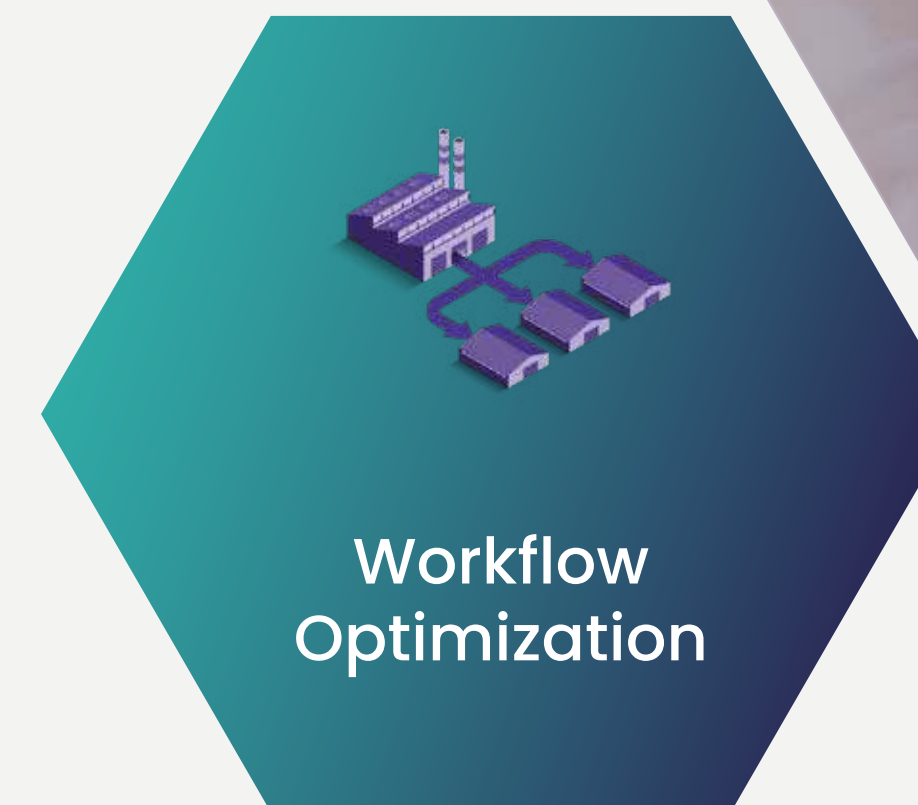
- ❖ **Priority:** Ensure AGEC compliance before the new labels were in circulation.
- ❖ **Timeline:** More time allowed for workflow optimization and backend preparation.

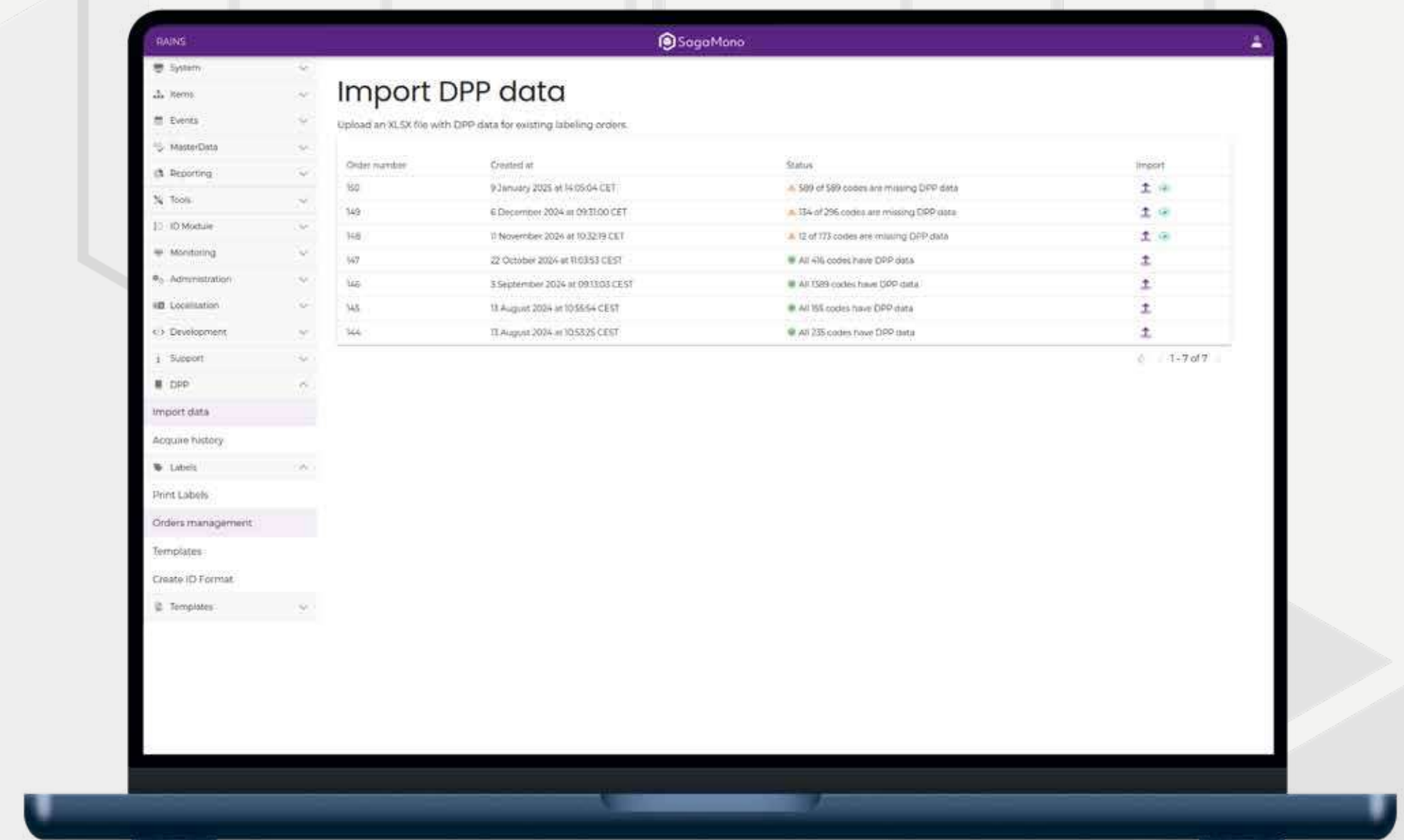
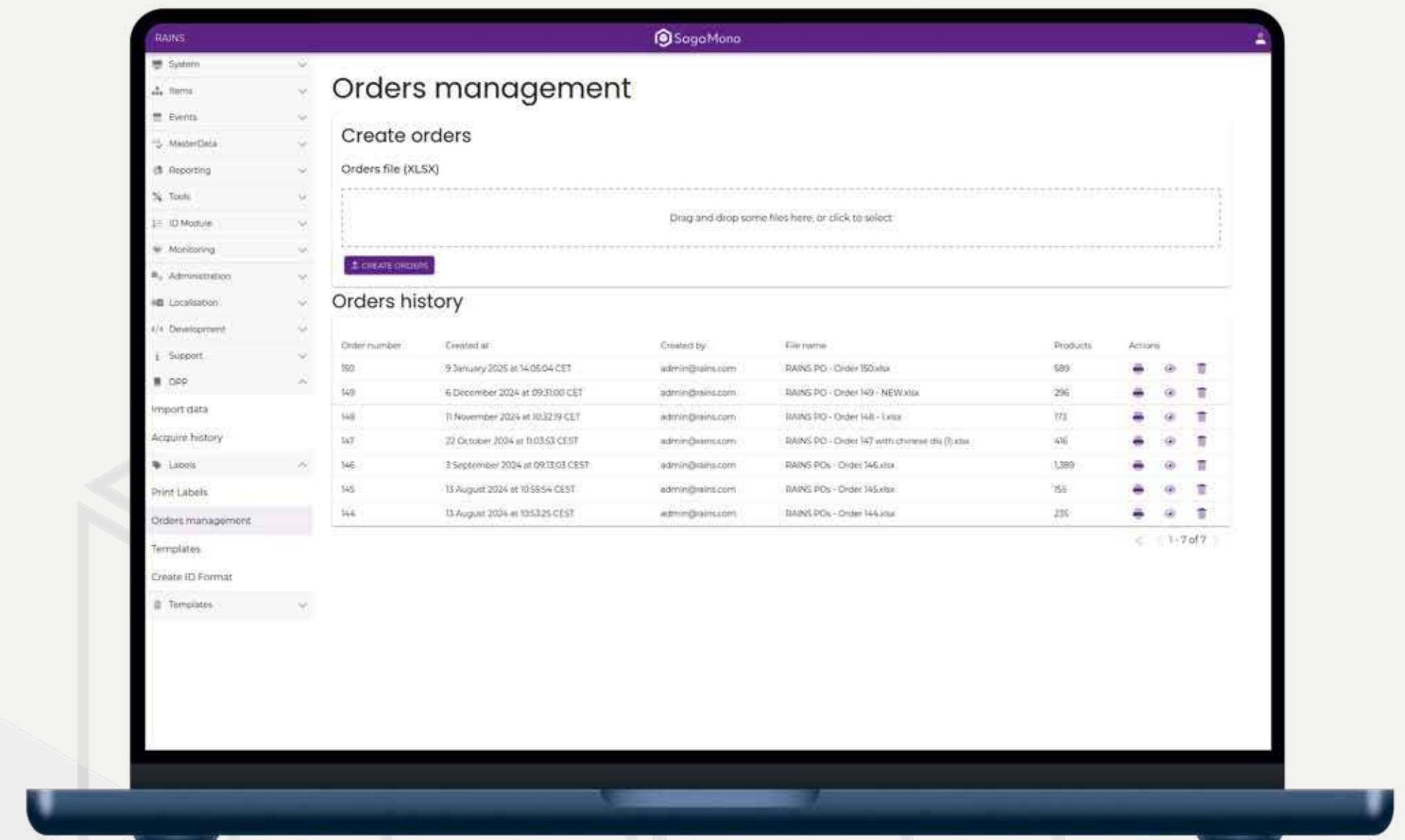
The Solution

How PSQR Addressed RAINS' Challenges

Introducing Saga: A Modular & Interoperable Traceability Solution

Saga provided RAINS with a **centralized system** to store and manage AGEC compliance data. Key features included:

- ❏ **Production Orders Management:** ERP integration via file uploads.
- ❏ **Care Label Generation:** QR codes with GS1 Digital Link encoding for seamless traceability.
- ❏ **DPP Data Management:** Integration for future Digital Product Passport (DPP) readiness.
- ❏ **Public Frontend for Compliance Data:** A default interface to display AGEC & DPP information to customers.
- ❏ **Data Change History:** Ensuring full traceability and compliance tracking.



What made PSQR's approach unique?

PSQR ensured that all necessary product details were structured and accessible, including:

1 Production & Distribution Data
Locations where products are made, imported, and sold.

2 General Product Information
Name, image, description, and public website link.

3 Label Printing
Ensured seamless generation and application of compliant tags.





Working with PSQR was a constructive and collaborative experience for RAINS. From the beginning, their team demonstrated a solid understanding of our compliance challenges and delivered a solution tailored to our needs. The implementation process was efficient, and we were able to get a working QR code labeling system up and running within a short timeframe, allowing time for internal testing and refinement ahead of production.

Beyond AGEC compliance, the solution has provided us with a scalable foundation for future needs. By consolidating product data and integrating with our internal systems, we are now better prepared for upcoming requirements like the Digital Product Passport.
